RESOLUTION #431-25 ADOPTING THE PRELIMINARY 2026 TOWN BUDGET

WHEREAS, pursuant to New York Town Law, the Town has prepared a Tentative Budget for the 2026 fiscal year; and

WHEREAS, the Town Board has completed its review of the Tentative Budget and any modifications thereof; and

WHEREAS, pursuant to Town Law § 106, the Town Board wishes to approve the Tentative Budget, along with any modification thereto, which shall become the Town's Preliminary Budget.

NOW THEREFORE BE IT RESOLVED, that the annual Preliminary Budget of the Town of Mount Pleasant and the several districts therein contained, for the year 2026, having been completed, the same shall be filed in the office of the Clerk of the Town of Mount Pleasant where it shall be available at all reasonable hours for inspection, and that this Board will hold a public hearing thereupon, at a meeting to be held at the Town Hall, located at One Town Hall Plaza Valhalla, New York, on the 25th day of November 2025, at 7:00 P.M.; and

BE IT FURTHER RESOLVED, that notice of said public hearing shall be posted in Town Hall and published in the Journal News, at least five (5) days prior to the public hearing; and

BE IT FURTHER RESOLVED, that at the time and place of the Public Hearing the Town Board will meet and review the Preliminary Budget and any interested persons may be heard in favor of or against all or any of the items in said preliminary budget.
